New Club Application

The Albury Wodonga Football Association (AWFA) has a proud history in Albury Wodonga and its surrounding district having been formed in 1973 with just 5 clubs.

Today, the AWFA has 11 Member Clubs and 1 Associate Club who collectively have more than 2,500 registered players and members.

The AWFA welcomes new Clubs to apply for membership and applications will be assessed on the following criteria (but not limited to):

- Club Name and Colours;
- Competitions requested;
- Location of Club and Facilities available;
- Club Financial Position;
- Club History, Management and affiliations
- Disciplinary History; and
- Coach Education Structure.

As per the AWFA Regulations (Bylaws), Clubs must apply as per Rule 1.3.1 -Application for affiliation by the 30^{th} of September to be considered for the upcoming season.

Applications received after this date may be considered if vacancies exist.

Requirements for affiliation

You will need to complete the Application Form (AWFA02) and provide the appropriate documentation to the AWFA for consideration.

If you are unable to meet any criteria at this stage of your application, please provide details of which criteria you cannot meet and the AWFA will endeavour to assist you.

Club Name and Colours

Proposed Club Name

1. Your club may not share the name of any other club already affiliated to the AWFA and must comply with FA's National Club Identity Policy, excluding traditional football names such as City and United.

2. The AWFA reserves the right to not accept a name if it is deemed unsuitable.

Please ensure that the name you have inserted above is compliant with the stated requirements, otherwise you will be required to amend it until the AWFA is satisfied with the outcome.

Colours and Playing Strip

All Clubs, as per Regulation 1.3.3., must nominate their club colours (maximum of four colours) for consideration and acceptance by the AWFA Executive Committee (EC).

For the purpose of the above, details of colours shall include colours, pattern and style of shirts, colours of shorts, colours and pattern of socks and colour and pattern of goalkeeper's uniform. No part of the player's attire or the uniform worn by a club official may incorporate national flags, slogans or emblems.

Advertising on a strip is permitted except for the advertisements which contravene state or federal laws (such as tobacco advertising), the AWFA Regulations and By-Laws, advertise products, brands or companies which are in direct conflict with the AWFA protected sponsors or damage the reputation of the league or the Association.

No advertising relating to alcoholic beverages may appear on the playing strip of any player under the age of 18. The AWFA reserves the right to require that sponsorship advertising is removed from a playing strip if it deems the advertisement breaches the Associations Competition Rules.

If the Club's application is successful, the Club must be registered with Football Australia (FA) prior to the commencement of the season and in accordance with the National Registration Regulations through the FA Prescribed Form NRR02- Application for Registration of Football Club.

All clubs are required to adhere to the FA Registration Regulations. A club must not field any person in any match unless that person is registered as a player with that club and deemed eligible in accordance with FA Registration Regulations.

Each club is required to have a Club official capable of using online based systems and daily access to the internet and email.

The club MUST familiarise itself with the Association's Constitution and Bylaws.
